COMMERCIAL CANNABIS BUSINESS ACTIVITY OPPORTUNITY SUMMARY SHEET

Listed below are the commercial cannabis business license types permitted within the City and the current number of available licenses. Unless a specific application deadline is identified, applications will be accepted and processed in the order they are received until all available licenses have been allocated.

COMMERCIAL CANNABIS DISTRIBUTION LICENSE:

The City allows for a maximum of four (4) Commercial Cannabis Distribution Licenses. There is currently one (1) Commercial Cannabis Distribution License available.

COMMERCIAL CANNABIS LABORATORY TESTING LICENSE:

The City allows for a maximum of four (4) Commercial Cannabis Testing Licenses. All four (4) Commercial Cannabis Testing Licenses are available.

COMMERCIAL NON-STOREFRONT RETAILER CANNABIS FACILITY LICENSE:

The application process for the four (4) Commercial Non-storefront Retailer Cannabis Facility licenses will open on May 17, 2021 for a 45-day period. Applications will be available from the Community Development Department located in City Hall and on the City's website at www.lahabracity.com. For questions regarding the application process, please review the information on the webpage which outlines the application process, required materials, and other information necessary to operate a Commercial Non-storefront Retailer Cannabis Facility in La Habra. To be considered for issuance of a Commercial Non-storefront Retailer Cannabis Facility License, final applications **must be** submitted by June 30, 2021 to the Community Development Department located at 110 East La Habra Blvd., La Habra, CA, 90631 by appointment. This application process is adopted pursuant to La Habra Municipal Code 18.22, Commercial Cannabis Activity.

CITY'S RESERVATION OF RIGHTS

The City reserves the right to request and obtain additional information from any candidate submitting a proposal. Late proposals WILL BE REJECTED when a specific deadline has been established. Furthermore, a proposal RISKS BEING REJECTED for the following reasons:

1. It is not responsive to requirements of the Step-by-Step Guide-Cannabis Business Permit Application, Cannabis Business Application Submittal Checklist and Cannabis Business Permit Application.
2. The issuance of a specific Cannabis Business License type applied for at the proposed location is inconsistent with the state law, LHMC Chapter 18.22 (Commercial Cannabis Activity) or any other applicable City of La Habra ordinance.

AMENDMENTS TO THE APPLICATION

Applicants will not be allowed to make amendments to their application or to supplement their application, except as otherwise specifically permitted in these procedures or as authorized in writing by the Director of Community and Economic Development or his/her designee.
